Introduction


The Medical Radiation Technologists Board (the Board) extends its thanks and appreciation to the individuals and groups who provided feedback to a recent (September 2019) consultation on the revised policy document *Code of Ethical Conduct for Medical Imaging and Radiation Therapy Practitioners in Aotearoa New Zealand.*

Consultation Response Rate

138 responses were received with 2 of those submitted from a group stakeholder perspective (the NZ Institute of Medical Radiation Technology and the Australasian Sonographers Association).

The 136 submissions received from members of the medical imaging and radiation therapy profession equated to 4% of the total number of practitioners who hold a current practising certificate which represents a relatively small response rate.

Board Deliberation and Decision

The Board noted that the high percentage of respondents agreed with the each of the revised standards as set out in the *Code of Ethical Conduct* document. A number of relatively minor amendments have been made to the document based on respondents' feedback.
