Accreditation and Monitoring Fees

The Board does not set a standard fee for carrying out an accreditation review of a New Zealand education provider, or examination provider, but will instead issue an itemised invoice for reimbursement of costs associated with the accreditation review. All such invoices are calculated on a cost-recovery basis only.

* An *initial APC* or *RTW APC* will be issued up until 31 March. Please note, this APC fee is **only** available for those applying for an initial APC, or for those returning to practice after a period of time away from practice.

* The fee for a 'first APC' is payable by those applicants who have completed an accredited programme of education.

* The disciplinary levy is for a 12-month period.
