# Introduction from the Chief Executive

Kia ora koutou

Ko Sue Calvert tōku ingoa | My name is Sue Calvert and I have recently been appointed as the Chief Executive of the Medical Radiation Technologists Board. I am honoured to take up the role and would like to acknowledge the great legacy that the Board's long-serving previous CEO, Mary Doyle left.

I have come to this role with a background in health and regulation. After graduating from the University of Canterbury in the 1980's, I started my working life in the business sector. However, I very quickly changed direction and have been working in health for more than 30 years. I have worked as a midwife in a number of roles across the clinical practice, research and education areas. Over the last 14 years I have held a number of regulatory leadership positions including professional advisor, registrar, and Chief Executive. I come to this role at the Medical Radiation Technologists Board with a solid understanding of the health professional regulatory environment and the importance of public safety.

As regulators our purpose is to protect the public by ensuring that practitioners are competent and fit to practise their profession. We do this by setting standards for entry to the profession and requiring clinicians to engage in ongoing development. Having identified the demands on clinicians and the changing and complex clinical environment in which they practice, my doctorate focused on how a group of practitioners maintained their ongoing competence to practise their profession. My research highlighted, at the time, that clinicians identified areas in which they needed to develop their practice and managed issues such as resourcing and availability of education in order to maintain their competence. I am aware that the past few years have brought more challenges to health professionals. It has also highlighted the crucial role that you play in the provision of care to the public. I was recently at a function where I was able to speak with students from a number of health professions. Their energy, enthusiasm, and desire to make a difference to the experience of whānau was inspiring.

In order to be effective in my role as Chief Executive I see it is vital to create and maintain effective relationships across the sector. While I have only been in this role a few weeks, I am considering strategies that can enhance stakeholder engagement and communication. The Board has a solid workplan which includes work on cultural competence as well as a review of the scopes of practice frameworks and I look forward to engaging with you as we progress this work.

I want to take this opportunity to acknowledge those of you who have been impacted by the recent weather events that have led to the state of emergency. I also want to acknowledge those who have provided assistance in support of colleagues. We are currently in the midst of our practising certificate renewal cycle and my team are doing a great job of processing your applications. While many of you have already applied for and been granted your practising certificate, if you have been impacted by the cyclone, please do not hesitate to contact the Board if you need to speak with us about your application.

The renewal process for your 2023/2024 practising certificate opened on 14 February 2023 and remains open until close of business 31 March 2023.

## Medical Radiation Technologists Board CPD Audit Reminder

As a reminder, practitioners selected for audit this year will have to provide one years' worth of CPD relating to CPD activities they undertook between January – December 2022. Practitioners who are selected for audit must provide evidence that they have engaged in at least 10 hours of CPD in that time period.
